1 INTRODUCTION

The principal objects of Beaumont Tennis Club Inc. (the Club) are to;

- promote, encourage and administer the game of tennis for members of the Club,
- provide and maintain facilities for the members of the Club,
- provide access to tennis facilities for the residents of the City of Burnside.

2 PURPOSE OF THIS POLICY

The main objective of the Club's ("our", "us" or "we") Court-Usage Policy (this policy) is to define the rights of Club members and members of the public to use the Club's courts and assign priorities for their use.

3 COURT-USAGE PRIORITIES

The priorities are:

- 1. Inter-club matches;
- 2. Club tournaments;
- 3. Coaching;
- 4. Training or practice by Junior members before 6 pm on weekdays;
- 5. Training, practice or social play by Senior members after 6 pm on weekdays;
- 6. Senior playing (competition) members have priority after 6 pm on Thursdays (Social members can play if court space is free);
- 7. Casual use by members of the public.

COURT-USAGE POLICY

4 USE OF COURTS 1 - 4

The Club has priority for the use of these courts. The normal times of use are:

• Monday: 3:30 pm – 10:00 pm (lights may be used until 8:00 pm);

Tuesday: 3:30 pm – 10:00 pm;
Wednesday: 3:30 pm – 10:00 pm;

• Thursday: 3:30 pm – 10:00 pm (lights may be used until 8:00 pm);

Friday: 5:30 pm – 10:00 pm;Saturday: 8:00 a.m. – 10:00 pm;

• Sunday: 8:00 a.m. – 10:00 a.m. & 2:30 – 10:00 pm

The public is welcome to use these courts when **not in use** by the Club.

5 USE OF COURTS 5 - 7

These courts are not normally available for use by members of the public.

Coaching has priority over training, practice or social play by Senior members until 7:30 pm Monday to Wednesday (7:00 pm on Thursday).

6 TO WHOM THIS POLICY APPLIES

This policy applies to everyone wishing to play on the Club's courts.

7 CLUB RESPONSIBILITIES

The Club will:

- Manage the schedule of court-usage for matches, coaching, training and social play;
- At its discretion, make courts available for use by members of the public.

Members of the Club's Management Committee are responsible for the application of this policy. Authorised representatives in order of authority to advise are Office Holders, Senior and Junior Tennis Coordinators, Coaches, Committee Members and then Club Members, as appropriate.

8 INDIVIDUAL RESPONSIBILITIES

Anyone wishing to play on the Club's courts must:

- Abide by this policy;
- Respect decisions made by the Club's authorised representatives;
- Respect all users of the courts and the equipment and associated materials provided by the club to facilitate access and use of the courts.
